### A message from Pastor Aida

Beloved siblings in Christ,

Peace to you all from the One and Triune God!

It's been a minute since my first day with ALC, May 21, 2024 to be specific. I've been building relationships and observing as well. During the last eight months I've been working with all three communities and now I have a better understanding of ALC: its strengths, its lack, its wants and its needs. Some of them I have communicated with leadership, others I'm still pondering on. I have received love and challenges equally and for that I'm grateful, and I think we've had some fun along the way. Here are some thoughts that I have shared with leadership that in my opinion should be crucial:

- 1. I have seen how ALC is still in recovery from the pandemic, and due to the lack of stability this process has been even more difficult.
- 2. The structure needed for this type of multi-ethnic and program ministry needs some TLC.
- 3. The concept of community within the particularities of ALC needs to be addressed in an intentional way.

As we work on those three aspects of ministry then wants and needs should be taken care of like music, quality and volunteers for livestream, Confirmation Classes, and Youth and Children Ministry. Let me tell you that the leadership and myself have been working non-stop with many of those things already.

I've heard comments full of hope, and some a little pessimistic, that's normal. As you approach this time of discernment, I pray for ALC and I ask ALC to pray for this pastor as well. May the Holy Spirit guide us all as we make decisions for the sake of ALC's ministry.

During this time know that I'm available for one-on-one conversations if you would like to hear more on the things mentioned above.

## **IF YOU INTERACT WITH ICE AGENTS AT WORK**

- 1. Ask if you are free to leave. If so, you may calmly walk out.
- 2. You have the right to refuse consent to a search.
- 3. You have the right to remain silent. You do not have to discuss your immigration status with anyone, such as about where you were born, whether you are a citizen, or how you entered the country.
- 4. If you have valid immigration documents, you should show them. Never provide fake documents.
- 5. If you are arrested, say that you wish to remain silent until speaking with a lawyer.
- 6. You have the right to record your interaction with immigration agents as long as you do not interfere.

# More Than a Roof Campaign Exceeds Goal



Our More Than a Roof three-year campaign that began in January 2022 with promises of \$508,866 came to a close on December 31st.

Thanks to an exceptional response at the end of the year, we have exceeded intended gifts by \$77,016! We are so grateful for the faithful and generous gifts that have been made.

Did you know that the total cost of the new roof and air conditioning units was \$863,600? A 20-year loan with the Mission Invest Fund allowed Ascension to undertake this project. The \$585,882 contributed has been applied to the loan but Ascension will carry the debt that remains (approximately \$280,000) for the coming 17 years. We are grateful to learn that there are contributors who intend to extend their giving to the fund to help reduce this debt. We invite you to join these faithful contributors.

### **Treasurer's Report**

#### Happy New Year, Ascension!

2024 was sure a busy year for our congregation, and an ambitious one as we set out to search for new community partners in our space, renew our current relationships, and began forming our pastoral staff.

I wanted to provide a transparent draft of where we ended our year financially, and reflect how far we have come. In 2023, we ended our year with a \$131,305.16 deficit, due to the costs associated with a full restoration of our kitchen and dining room, along with other building needs that came up throughout the year.

Going into 2024, we set an ambitious goal to cut this deficit down to only \$40,000 (a nearly 70% reduction!!). While we did not meet that goal exactly, we DID cut our deficit by 45%, which includes an additional \$45,000 toward roof principal payments. (Normal monthly roof payments are factored into our accounting, as well.) (Deficit is defined as an excess of expenditure over income or assets in a given period.)

For 2025, we are starting the year with increased rental revenue from two of our current partners and exploring a new lease with one of them, as well, to have greater use of our facility, bringing new life into our north and south wings! There is also a dedicated team of individuals exploring grant possibilities and planning enhance programming possibilities for our youth and faith formation. All in conjunction with now maintaining a pastoral staff of one full-time pastor, which will be reflected in my proposed budget on Sunday, March 16<sup>th</sup>, at the annual meeting.

Our cash position remains stable, and endowment remains healthy and growing, with the guidance of our financial advisors and Endowment Board. If you have any questions or concerns, please feel free to contact me at 414-758-4079!
